



#### Testimony of Eric Rasmusen on S.B. 202, Universities

1. The section on DEI Statements should be amended by inserting "or suggest to" so it reads

(b) An institution may not require OR SUGGEST TO an applicant, an employee, or a person described in subsection(a) that he pledge allegiance to or make a statement of personal support for any:

Otherwise, a university can say in its job ad that a DEI statement is optional--but then quietly discard all applications lacking a DEI statement.

2. The sections on tenure and post-tenure review need drastic overhaul. As written, they provide too many pretexts for university faculty and administrators to persecute conservative professors. The problem will be selective enforcement: the University Administration will use the section against their enemies while ignoring its mandate as their friends do much worse things. Complaints will be put in files, but those files will not be read.

3. The sections on tenure and post-tenure review ignore non-tenure-track faculty, who may be 50% of all faculty. Nowadays, lots and lots of university teachers are both untenured and never come up for tenure. Called "Lecturers" or "Clinical Professors", they are permanent, middle-aged, employees who just teach and don't do research. The bill as written only applies to faculty tenure review or to faculty who have already achieved tenure, so it doesn't cover the non-tenure-track faculty. This was surely an omission by mistake.
