

Judges Henderson, Wilkins, and Rao,

Thank you for your time in reviewing my Amicus Brief submission pertaining to the trial of General Michael Flynn. Originally I had planned on sending my input to Judge Sullivan, but as things developed I realized your panel might be a more appropriate venue.

I'm not sure why I was drawn toward this specific case, but for well over two years now I've carefully reviewed court documents, poured over related trial testimony, and have even attended the proceedings in person.

My experience of being in the same room as the lawyers, reporters, and witnesses had a profound impact on my reading of what might be percolating beneath the surface of this world famous trial. I observed Brandon van Grack, of the Mueller team, seem particularly anxious... almost scared... as he shuffled court papers while waiting for court to begin. He struck me as someone who was involved in something he shouldn't be involved in (as did his co-counsel). In short as I was watching the trial "live", an old Southern phrase sprang to my mind, "Something in the milk ain't clean.

Little did I know at the time.

Due to time constraints, please allow this paragraph to serve as an outline of my contribution. (And please forgive me to resorting to using bullet points in places because the June 5<sup>th</sup> deadline for Amicus submissions is rapidly approaching.) I would first like to touch on some key data points that will further bolster General Flynn's position—the recent avalanche of declassified documents makes it rather challenging for a "non-obsessed observer" to ascertain all the useful nuggets of information now available to the public. Next I will address some of the points that Judge Sullivan's representative, renowned Attorney Beth Wilkinson, has developed as a "defense". Or maybe an explanation is a more fitting term... as you have surely noticed I have had zero training in the law. Lastly I will ask a series of questions, some rhetorical, that get to the "Why?" of this perplexing case. A case that has a rather unpleasant underbelly.

It is my hope that I am able to shine some badly needed sunlight on the darker aspects of this long-running saga through my Amicus Brief.

A partial list of the above mentioned documents that include helpful material to General Flynn include:

- \*House Permanent Select Committee on Intelligence interviews recently released by Acting Director of the O.D.N.I. (Richard Grenell) There are a total of 53 interviews included in the latest release.
- \*Newly released Brady Materials including the infamous edited 302's and "frame job" language used by F.B.I. investigators. Items came through Attorney General Barr's office
- \*The entire Bijan Kian Trial—this is a seldom touched on treasure trove of data points including 30 plus pages of General Flynn's Grand Jury Testimony
- \*The "inadvertently" misplaced/hidden documents from the General's original team of lawyers from Covington and Burling

I'm going to avoid the more common territory" like edited 302's and Strzok and Page emails. I don't think I can add insight to items like these. I do think it is helpful is I bring up some of the lesser discussed material... and how recent releases impact our collective knowledge base.

This case keeps coming back to Turkey. And the more it does, the better General Flynn looks over time. Initially mainstream reporters obsessed on the fact that General Flynn failed to register through F.A.R.A. in his interactions with Turkey. But it was his own Covington and Burling lawyers that advised him to hold off from registering. Odd, right? What if I told you that the Managing Director of Covington and Burling is "Wingman" Eric Holder. I find it very interesting that all of the helpful documents regarding General Flynn somehow disappeared into thin air. But when O.D.N.I.'s Richard Grenell (who I affectionately refer to as a badger because of his almost other worldly tenaciousness) showed everyone how serious he was by making massive drops into the public sphere—wow, all the missing docs mysteriously reappeared.

Again I'm no lawyer, but I looked up the definition of R.I.C.O. and wouldn't this qualify? If not, I think a penalty should be levied against the licenses of General Flynn's prior attorneys.

Then there is this... it's hinted, it's implied that General Flynn was going rogue regarding Turkey. The Bijan Kian trial doesn't show that at all. In fact Former Director of the CIA James Woolsey was involved in key meetings with Turkey's representatives—how is Flynn acting rogue when the highest officers of the CIA are involved in discussions. Side note: did Woolsey go to the James Clapper school of disinformation techniques? Even their speech patterns match.

And for historical purposes, it should be noted that President Trump was accurate regarding N.A.T.O. This international association had broken down into an elaborate U.S.A.I.D. rinse benefiting a few compliant U.S. politicians, a few more retired Generals and Admirals, and the entire Atlantic Council. Kian's trial was incredible for those that were paying attention. Europe got a free ride on their collective defense budgets and the American people were stuck footing the bill. Again.

Now if I could shift over to Beth Wilkinson's 36 page brief... to say she treats the General unfairly would be an understatement of epic proportions.

Wilkinson states, "the government... has not asserted an misconduct by the career prosecutors who previously oversaw the case."

Well if they won't, I will. How's this? Why did Team Mueller extort a Three Star General by threatening to imprison his son for five plus years in Federal prison? Over what we see now were mere political differences.
