As Twitchy reported earlier, a three-person appeals court panel gave Michael Flynn judge Emmet Sullivan until June 1 (https://twitchy.com/brettt-3136/2020/05/21/appeals-court-panel-givesjudge-emmet-sullivan-10-days-to-explain-what-hes-doing-with-themichael-flynn-case/) to explain what the court should do with Flynn's emergency request to force the dismissal of his case. 




